Canada vs UK for International Students



A handful names come to mind whenever anyone talks about studying abroad. No matter where your country of origin is, there are only 3-5 options to choose from when it comes to international education. These top countries for international education are the US, UK, Canada and Australia. It is because they are the most popularly chosen countries by the majority of students for international students. In the present article, we will only look at Canada vs UK for international students as these are the only two countries which confuse students.

There are many other international countries where students can pursue their university education; however, Canada vs UK for international students are the two most competitive countries to choose from when it comes to university education. It is because of the large number of prestigious universities that are

situated in these two countries. Out of the top 100 universities of the world, the UK alone houses 18 of them including, the University of Oxford, University of Cambridge, and Imperial College of London. Whereas, Canada has just over 3 internationally renowned colleges in the 100 list of universities, including the University of Toronto, McGill University and the University of British Columbia.

Pursuing your education abroad is a huge step and requires great investment; therefore, you need to do proper research and have all the information before you can make your decision. The guide on Canada vs UK for international students covers different aspects which you must consider before selecting a country to pursue your education from.

Tuition Fee

When it comes to choosing between Canada vs UK for international students, it is very important to take the tuition fees into consideration. Higher education doesn't come cheap, especially when you're planning to pursue it from an international country.

The average tuition cost in UK for undergraduate courses range from \$15,000 to \$30,000 per year. Whereas, a two-year post-graduate course in the UK will cost you \$15,000 to \$30,000 per year.

The average tuition cost of undergraduate courses in Canada ranges from \$10,000 to \$25,000 per year whereas, for a postgraduate degree in Canada, the tuition fee ranges from \$15,000 to \$35,000 per year.

Although both the countries offer cheap and expensive universities and colleges to choose from, however, if you wish to go for a university with cheaper tuition fees, then we suggest you explore the various colleges in Canada.

Accommodation and Cost of Living

Apart from tuition fee, accommodation and the living costs are the most important financial factors to consider when choosing between Canada vs UK for international students. Finding the right accommodation alone is a huge task for international students, and when you pile on additional daily expenses on top of it, the total amount becomes as high as the tuition fee itself.

The average cost of living in the UK is the most expensive, and ranges from \$18,000 to \$20,000 per year, including accommodation, groceries, and travel. The amount may go lower or higher depending on where you live, for example, the cost of living in most metro cities in the UK is quite high, whereas if you are living on the outskirts or away from the city, then you may find cheaper accommodation.

Canada offers the most pocket-friendly living costs to international students. The average cost of living in Canada ranges from \$7,000 to \$11,000 per year. The amount is considerably cheaper than the UK and combined that with the lower tuition fee, the difference becomes quite significant. In addition, the apartment and dorms in Canada are on an average much more spacious than the UK for the same amount.

Additionally, you cannot make any compromises when it comes to tuition fee, you can, however, change your lifestyle a bit and reduce your accommodation and other costs of living abroad. It might enable you to pursue your education at your dream college if you have any budget constraints.



Significance of Education from Canada vs UK for International Students

It is an important factor to look for when choosing between Canada vs UK for international students. Most students overlook this factor, but it is very important to understand what your educational qualification will amount to, once you've finished your education.

It is noticed that most of the universities in the UK are much older than universities in Canada. The UK has a rich background in the field of academics, engineering and technology, art, music architecture and innovation. The UK has given rise to some of the world's most leading personalities, such as Isaac Newton, Stephen Hawking, Charles Darwin and many more.

The rich heritage makes the UK one of the most sought after places to pursue your education from. In addition to the famous personalities, UK is also home to some of the world's leading and one of the world's oldest educational institutes. It doesn't necessarily mean that if you pursue your education from Canada, your degree will have a lesser value. Colleges and Universities in Canada are also quite popular among international students, as Canada offers courses in Business, Engineering, Nursing, Agriculture, Computer Science, Mass media and Hospitality. Canada has also given many great inventions to the modern world. Though the universities in Canada may not be as old as many institutions in the UK, however, they are equally prestigious and are ranked quite highly in the top universities of the world. Career Prospects

Majority of the students who go abroad to pursue their education from a different country tend to get settled over there, soon after their education is finished. No matter if you plan to settle in another country or if you wish to come

back home afterwards, you must consider the career prospects Canada vs UK for international students have to offer.

After you complete your education in any country abroad, you will be granted a post-study work permit, which will provide you with some time to get your career started. This time allotted to on your post-study work permit varies from country to country and keeps on changing. So you need to stay up to date with the current conditions of the country you are planning to attend college at.

In the UK, the post-study work visa gives you 6months to work in the UK after graduating from your university. In order to keep working in the UK after the post-study work visa, you need to apply for a tier 2 Visa. In order to apply for a tier 2 visa, you must have a minimum of \$20,500 annual wage. A tier 2 visa allows you to work in the UK for up to 5 years after your graduation.

Whereas, in Canada, students can work for up to 3 years depending on their course, after graduating from university. The post-study work permit in Canada allows students to find work in any field of their choice.

When speaking about career prospects, it is important to note the average salaries provided in Canada vs UK for international students. If you're working in the UK after your graduation, your average salary may range from \$35,000 to \$37,000 per year. Whereas, Canada offers an average salary of \$37,000 to \$40,000 to international students after graduation.

The difference may not seem much, but considering the investments made for the duration of your course while paying your tuition fee and living costs, this amount can play an important role. It is because, in addition to having cheaper tuition fee and cost of living, Canada offers a much higher salary on an average, whereas, the UK has a much higher cost of living and tuition fee, and provides a lower average salary.

Visa and Immigration Laws

The last and the most important factor that comes into play when choosing between Canada vs UK for international students study is the process of Visa application and Immigration. A lot of the students to pursue education abroad and continue to work there have a plan of staying there for some time and possibly get a permanent residency.

When we talk about settling in the UK, the process is a little tougher as the UK government is quite strict when it comes to immigrants from non-EU countries. In addition, the visa regulations and policies keep on changing due to the political shifts in the country. It makes getting a permanent residency in the UK that much more difficult.

However, this prospect is quite different from Canada. Canada is a very vast nation and has a small population of people living there. Therefore, the Canadian government openly welcomes skilled individuals who wish to pursue their education in Canada and work there on a Post-graduation work permit. During their post-graduation work permit, people can apply for a permanent residency as well. The government regulations and laws for getting a permanent visa in Canada are quite welcoming and fairly simple to get.

Therefore, you must prepare well and stay up to date with the latest news and updates regarding changes in visa conditions. You can visit news portals such as today's news post to learn about the latest developments regarding immigration and student visa guidelines.

In addition to these factors, there are some other possible considerations that you must take into account while choosing between Canada and the UK for international students. These factors range from:

It is the presence of a prestigious education system and a dynamic economy that attracts international students from different parts of the world to the UK. Study in UK for international students is the best choice if they are looking for a bright career in the future. The article on Study in UK for international students majorly deals with providing effective tips to be considered while moving to Britain.

Tips to be Considered to Study in UK for International Students

Create a student bank account in the UK

We recommended our readers to start a student account in the local bank of the UK. Online mode of payment is widely used in the country and starting an account would help the students in effortlessly paying their bills along with avoiding foreign exchange charges. Approach the bank as soon as you land in Britain since it takes a long verification process to start a student account. Checking whether your existing bank has any link with banks in the UK would help you in creating a student bank account in a much smoother and faster way. You should possess the below-listed documents to start a bank account in the UK.

1. Verifying document for the permanent address in the native country
2. A passport
3. A valid visa document (required only if you don't belong to the European Union).
4. Documents verifying the student status
5. Verifying document for the permanent address in UK (Any utility bill or tenancy agreement could be used for this)

The international students are allowed to take an interest-free overdraft up to the limit of £ 3000 from the local banks of the UK. (Note: – Not all banks in the UK provide the facility of starting student banks.)

It is strongly recommended that the students should consider ample money for one month's expenditure since it takes at least 10 days to get debit cards from the bank.

Organize appropriate funds for your research scholarships and academic course

Before planning to start study in UK for international students, it is recommended to ensure the required finance for pursuing the whole academic course. The amount of money would significantly vary as per the nationality of the student. Students coming from the European countries would not have to bear much expenditure since they already belong from the European economic area (These criteria may change after Brexit). There have been some confirmations and declarations from the British government that students from the European Union would be considered as overseas students after the academic year of 2021.



In the present scenario, international students coming apart from the European Union are not allowed to apply for loans in the United Kingdom.

Determine the restrictions on working hours

It is very tough for international students to bear the daily cost of London just by relying on the financial resources provided by the family. Working in a high paying part-time job would help you in garnering relevant job experience and financial support simultaneously.

The international students are only allowed to work for a total of twenty hours a week. Though there are no such restrictions on working hours at the time of course breaks.

Arranging student accommodation

We recommend our readers to make all arrangements for accommodation before arriving to study in UK for international students. The best and cheapest method would be to apply for the accommodation in university hostels. However, there would be a huge crowd to avail of accommodation in university hostels. The university hostels are self-catered and thus would protect the international students from the heavy expenditure of eating from restaurants.



Organize yourself with the British way of life

Unlike other countries, the British population is very receiving towards immigrants from all around the world. International students would not find themselves left alone in British universities since there would be a lot of fellow students from the same country in the educational institute. Try to interact in the Facebook groups of your university which would remove your anxiety and query regarding the particular issue.

We warn you that the UK experiences severe winter. It would be better to take precautions for cold and wet climate when preparing to study in UK for international students.

Ensure your health insurance

International students are strictly required to possess health insurance to pursue an academic course in the UK. Students belonging from the European Economic Area are required to hold a European Health Insurance Card. This would help the students in getting cheap healthcare treatment from the National Health Service Institute of the UK. Though, it should be noted that the extra expenses and treatment for grave injuries are not included under such health insurance.

1. Scotland Saltire Scholarships

The Scottish government in association with various universities in Scotland offer the Scotland Saltire Scholarships which provides 50 students with full coverage on their tuition fees for one whole year.

The value of the scholarship is up to 8000 Pounds covering the tuition fee of any year during the academic course for full-time post-graduation or masters' program in the field of Healthcare, Clean energy, creative industries and other fields of science and technology.

This scholarship is available for students from the USA, Pakistan, Japan, Canada, China and India. If you need more details about the scholarship, you can find it on their website.

2. GREAT Scholarships

The British Council and the UK government started funding this scholarship under the Study UK campaign. The scholarship offers a minimum of 10,000 Pounds or the tuition fees of one year for the postgraduate programme.

Currently, the scholarship covers 36 universities across the United Kingdom and 99 Postgraduate courses. You can check out the dates of application and eligibility criteria for GREAT Scholarships from their official website.



3. Commonwealth Scholarships and Fellowship

The scholarship is granted by the Commonwealth Scholarship Commission in the UK. It is directly controlled by the Department of International Development. The scholarship is provided to talented individuals who plan to study in the UK for their master's or doctorate degrees.

The scholarship covers tickets for air travel, tuition fees, and other living expenses. The scholarship takes special consideration for a student in developing countries having a lower economy.

4. Chevening Scholarship

It is one of the most lucrative UK scholarships for international students. It is offered to exceptional individuals with leadership skills and performance to show in their fields. The scholarship offers coverage for tuitions fees, living expenses, air travel and other expenses of international students.

5. Charles Wallace India Trust Scholarships

The scholarship is specifically for the students coming from the Indian subcontinent, in the field of arts, humanities and heritage conservation. The Charles Wallace India Trust provides various long-term and short-term scholarships to students pursuing masters and doctorate studies. They also offer funds for fellowship on specific works at Universities. The amount covered under this varies from program to program. The Charles Wallace trust offers UK scholarships for international students across many programs and courses.

UK Post Study Work Visa: The Recent Changes



It is a dream for an international student to find a reputable job in the United Kingdom after completing their academic course. The country of the United Kingdom provides a lot of opportunities for international students, and thus it is an excellent option to stay in the country after completing their academic courses.

The candidates are required to apply for a separate T4 student visa if they have decided to stay in the UK to start their job career. Every student who has completed his higher education in the country would be deemed eligible for a UK post study work visa, as per the new guidelines laid down by the immigration

department. It would enable the students to stay for a further two years in the United Kingdom. The period could be utilized by the candidates to work or to find a better profession in the country.

The government has included the provision of UK post study work visa to retain the best global talents in the national human resources. The nation is in high demand for talented human resources to mark its presence in the field of business, science and technology, industrial division, etc. It is from the Indian subcontinent that the country is expecting a massive influx of talented human resources. The human resources from the Indian subcontinent have the global reputation of being the cheaper workforce. In the year 2019, the immigration department of the United Kingdom has accepted around 96 % of the visa application from India.

The visa application of candidates with a PhD has a very high probability of being selected since the UK is looking forward to a leap in the field of Science, Technology, Engineering, and Mathematics (STEM). The government would announce a new graduate route for the candidates who complete their academic year of 2021. You could expect some significant changes in the policies in the wake of COVID 19 pandemonium. Though the government still needs to validate some sections, we have explained every vital aspect of the UK post study work visa in the below sections. Let us have a detailed look over it.

Eligibility requirements for UK post study work visa/ Graduate route visa.

The candidate should hold a Tier 4 visa after completing his graduation course in the United Kingdom. The candidates who would be considered for the UK post study work visa in the academic year of 2020 – 2021 would be: –



- Students who have started their one-year master's degree in the academic year of 2020 – 2021.
- Students who have started two years master's degree program in the academic year of 2019 – 2020.
- Students who have started their three-year PhD program in the academic year of 2018 – 2019.

The candidates who would complete their other graduate program in 2021 would also be considered for UK post study work visa. In simple terms, the students who

have started their PG program in the academic year of 2019 – 2020 will not be able to apply for the UK post study work visa. However, they are eligible to apply for the skilled worker tier 2 visa in the United Kingdom.

Process to be followed when the UK post study work visa expires

The candidate is required to either apply for a new visa or leave the country after the expiry of the UK post study work visa in two years. After the expiry, the candidate is only allowed to apply for a general work visa. A general work visa could only be permitted if the applicant would provide the proof for minimum salary or skills. In short, you should possess an occupation that comes under the guidelines of the Tier 2 visa. The profession providing the salary above £ 30,000 annually would be considered eligible for a general work visa.

It should be taken into account that the student doesn't require a job to apply for the UK post study work visa. If the candidate remains unemployed, the visa period will not get affected.

Role of University in acquiring UK post study work visa

The eligible candidates could apply for the UK post study work visa irrespective of the universities in which they have studied. The only regulation in this aspect is that the university should be recognized by the British government. The criterion should always be checked by the international students since most of the universities often lose their recognition from the British government for defying the visa regulations and withholding poor track record in education standards.

Role of studied course in acquiring UK post study work visa

Government of the United Kingdom has levied no restriction on this outlook and hence the candidates from any academic stream could apply for the UK post study work visa. The visa rules for post-graduation programs in the STEM field were already relaxed by the government in 2019. As per the new policy, the rules and restriction would be reduced for all of the graduate programs.

NOTE: – The candidate is expected to have pursued a full graduation course in the above context.

Requirement of sponsors for acquiring UK post study work visa

The applicant doesn't require a sponsor for acquiring a UK post study work visa. It would be a huge advantage for international students since the acknowledgement from the employer is required in other working visas. The government of the UK would consider the university of the student as the sponsor, provided that it is registered in the recognized list.

Impact of Brexit over UK post study work visa.

It is estimated that the exit of Britain from the European Union would significantly curtail the rights of EU citizens in the UK. The new policies in the UK post study work visa have eliminated such suspicions by classifying EU students under Tier 4 visa. Now EU students also have to apply for UK post study work visa to stay further in Britain. The framework for Brexit is still under progress, and we would update you if there is any significant change in the policy.



Would graduates getting affected by the outbreak of COVID 19 also be considered for a UK post study work visa?

The international students who are continuing their courses through online media would be considered for the UK post study work visa if they would arrive back to the country before April 6, 2021. The students have to complete the course via face to face classes after this date.
